This means the effect of the earlier AUDIT POLICY ... EXCEPT statements are overridden by the latest AUDIT POLICY ... EXCEPT statement. Note: \* The ORA\_DATABASE\_PARAMETER policy audits commonly used Oracle Database parameter settings. By default, this policy is not enabled. \* You can use the keyword ALL to audit all actions. The following example shows how to audit all actions on the HR.EMPLOYEES table, except actions by user pmulligan. Example Auditing All Actions on a Table

By default, 0 is the redacted value when Oracle Database performs full redaction (DBMS\_REDACT.FULL) on a column of the NUMBER data type. If you want to change it to another value (for example, 7), then you can run the DBMS\_REDACT.UPDATE\_FULL\_REDACTION\_VALUES procedure to modify this value. The modification applies to all of the Data Redaction policies in the current database instance. After you modify a value, you must restart the database for it to take effect. Note: \* The DBMS\_REDACT package provides an interface to Oracle Data Redaction, which enables you to mask (redact) data that is returned from queries issued by low-privileged users or an application. \* UPDATE\_FULL\_REDACTION\_VALUES Procedure This procedure modifies the default displayed values for a Data Redaction policy for full redaction. \* After you create the Data Redaction policy, it is automatically enabled and ready to redact data. \* Oracle Data Redaction enables you to mask (redact) data that is returned from queries issued by low-privileged users or applications. You can redact column data by using one of the following methods: / Full redaction. / Partial redaction. / Regular expressions. / Random redaction. / No redaction.

Explanation: \* Oracle Database provides a mechanism to make table structure modifications without significantly affecting the availability of the table. The mechanism is called online table redefinition. Redefining tables online provides a substantial increase in availability compared to traditional methods of redefining tables. \* To redefine a table online: Choose the redefinition method: by key or by rowid \* By key--Select a primary key or pseudo-primary key to use for the redefinition. Pseudo-primary keys are unique keys with all component columns having NOT NULL constraints. For this method, the versions of the tables before and after redefinition should have the same primary key columns. This is the preferred and default method of redefinition. \* By rowid--Use this method if no key is available. In this method, a hidden column named M\_ROW\$\$ is added to the post-redefined version of the table. It is

recommended that this column be dropped or marked as unused after the redefinition is complete. If COMPATIBLE is set to 10.2.0 or higher, the final phase of redefinition automatically sets this column unused. You can then use the ALTER TABLE ... DROP UNUSED COLUMNS statement to drop it. You cannot use this method on index-organized tables. Note: \* When you rebuild an index, you use an existing index as the data source. Creating an index in this manner enables you to change storage characteristics or move to a new tablespace. Rebuilding an index based on an existing data source removes intra-block fragmentation. Compared to dropping the index and using the CREATE INDEX statement, re-creating an existing index offers better performance.
