If any of these attributes are specified, they are ignored.* Oracle introduced Automatic Segment Storage Management (ASSM) as a replacement for traditional freelists management which used one-way linked-lists to manage free blocks with tables and indexes. ASSM is commonly called "bitmap freelists" because that is how Oracle implement the internal data structures for free block management.Note:* Buffer busy waits are most commonly associated with segment header contention onside the data buffer pool (db cache size, etc.).* The most common remedies for high buffer busy waits include database writer (DBWR) contention tuning, adding freelists (or ASSM), and adding missing indexes.
